ICP FILING

What is ICP Filing?

ICP filing is the essential system that an individual or entrepreneur applies for and obtain approval for providing internet/online (ICT) service regardless of contents in China.

! Important point

- All websites in China should receive "ICP filing".
- Site closing, access shut-off, access error, research and registration failure in case of failure to receive ICP filing.

ICP Filing Consulting

ICP Filing Issuing Conditions

- There should be a corporation in China. (including foreign-funded enterprise)
- Website should be operated at server in China.
- There should be a person in charge of ICP filing contactable.
- Domain owner should be same as the corporation applying for ICP filing.

How to Cope with Network Safety Act, Alibaba Cloud

Alibaba Cloud and MEGAZONE support Go China business

Overview and Main Contents of Network Safety Act of China (中华人民共和国网络安全法)

01. Overview

Cyber security act of Chinese government aiming to reinforce control on Internet for safety and order of national security and network space.

02. Main Contents

1. Reinforce standards of handling personal information and data
 - Personal information and important data collected and operated in China should be saved in China (Article 37).
 - Related institutes should carry out safety evaluation when sending such data outside China.
2. Implement network security grade protection system
 - Establish the network safety management manual, designate the responsible manager and keep the network related log for at least 6 months (Article 21).
3. Reinforce the process of handling and preventing network security accident
 - Establish emergency treatment plan to cope with network security accident and receive examination (Article 25).
 - If any security accident occurs, immediately report to the user and related departments and take actions according to request of related institutions (Article 22, 55, 56).
 - Give technical cooperation and support for screening of Chinese government (Article 28).
 - Carry out inspection and evaluation at least once a year for network safety and risk, reinforce analysis and evaluation and submit the results to the institution in charge (Article 26, 29, 38).
 - Establish anonymous letter and reporting platform for network information security, announce and handle information (Article 49).

Effects on Company

- China is expected to introduce in full scale and implement the regulation on 'transfer of important data outside country' of foreign companies which was delayed.
- Assignment of global companies advancing into China: need to manage data on management managed through the server at the head office of the home country in ICT system in China.
- Breach of regulation will result in punishment including fine up to 500,000 RMB, suspension of business, closing of website and cancellation of business license depending on degree of violation.

Support of MEGAZONE

- Evaluate safety and approve when transferring data to China with cloud service or taking out personal information and important data.
- Confirm compliance of Network Safety Act such as license of business in China and list of data transfer outside China through Alibaba Cloud and MEGAZONE consulting, and prepare compliance plan.
- Carry out security grade examination as the system safety evaluation is obligated with Network Safety Act in China (June 1, 2017).
